- Agricultural pest control.** This category includes commercial applicators using or supervising the use of pesticides in production of agricultural crops, including without limiting the foregoing, tobacco, peanuts, cotton, feed grains, soybeans and forage; vegetables; small fruits; tree fruits and nuts; as well as on grasslands and non-crop agricultural lands.
- Industrial, institutional, structural and health related pest control.** This category includes commercial applicators using or supervising the use pesticides in, on, or around food handling facilities, human dwellings, institutions, such as schools and hospitals, industrial facilities, including warehouses and grain elevators, and any other structures and adjacent areas, public or private; and for the protection of stored, processed, or manufactured products.
- Ornamental and turf** This category includes commercial applicators using or supervising the use of pesticides to control pests in the maintenance and production of ornamental trees, shrubs, flowers, turf, including the maintenance of resort grounds, golf courses, or green houses.
- Right of Way.** This category includes commercial applicators using or supervising the use of pesticides in the maintenance of public roads, electric power lines, pipelines, railway rights-of-way, or other similar areas.

REMINDERS:

Arrive on Time.

Candidates must arrive on time. If you arrive after the exam proctor begins instructions, you will not be admitted to the exam room.

Items to Bring.

- a) Valid photo Identification b) Two (2) Number 2 pencils c) Calculator

(Use of calculators is permitted, but is limited to only non-printing calculators, battery or solar powered electronic calculators that are not capable of storing or transmitting text information i.e.... Scientific Calculators and Cellphones)

Items not allowed include: Study notes, books, or materials.

After the Exam

Once a candidate has completed the exam and name and answer are reviewed for legibility, the candidate may leave the exam room. Results shall be only provided to the candidate in writing by mail within five (5) business days. Successful candidates, upon receipt of the exam results, may apply for his /her certification card with DEQ. Certification is \$50 for commercial applicator and \$10 for private applicator. ****Unsuccessful candidates, upon receipt of the exam results, may retake the written examination within a 90-day period, but must resubmit a registration form to reserve a seat at the next scheduled exam.**
